- 1. Joint program implemented by the AICPA & CIMA and SGH Warsaw School of Economics, hereinafter: the "CGMA University Program")
- 2. The CGMA University Program is intended for students majoring in:
 - 2.1. Finance and Accounting
 - 2.2. Management
- 3. The CGMA Program at SGH covers the following levels of the CGMA Professional Qualification and offers the students an opportunity to obtain a respective CGMA designation:
 - 3.1. Certificate level: Certificate in Business Accounting (CGMA Cert BA);
 - 3.2. Operational level: Diploma in Management Accounting (CIMA Dip MA);
 - 3.3. Management level: Advanced Diploma in Management Accounting (CIMA Adv Dip MA).
- 4. CGMA Program students complete the educational program mapped by the University against the CGMA syllabus, which is approved by AICPA & CIMA.

- 6. In order to complete the CGMA University Program and obtain a CGMA certificate/diploma, students are obliged to:
 - 6.1. read CGMA Program's policy and accept its provisions;
 - 6.2. enrol for the CGMA Program via USOS;
 - 6.3. register at www.cimauczelnie.pl and enclose required documents;
 - 6.4. register with ACIPA & CIMA;

- 6.5. Complete an educational program, mapped by the University against the CGMA syllabus, pursuant to point 5;
- 6.6. Pass a standardized external CIMA's CGMA exam before the end of the last semester (for Bachelor students) or before the end of the calendar year in which they graduate (for Master students;
- 6.7. Pay any fees related to their participation in the CGMA Program and external exam.
- 7. AICPA & CIMA and the University reserve the right to remove the student from a CGMA Program roster if the candidate fails to take CIMA's CGMA exam(s) and/or fails to pay applicable fees and/or violates any AICPA & CIMA's terms and conditions.
- 8. Students who meet all requirements indicated above and complete the CGMA University Program will be sent a certificate after 12 weeks from receiving the 'pass' result of their final exam at each level.
