

CGMA University Program fees 2024

1. Students participating in the CGMA University Program are obliged to pay the following fees to AICPA & CIMA:
 - 1.1. a one-off, non-refundable registration fee;
 - 1.2. external exam fees;
 - 1.3. annual subscription fee.
2. Timely payment of all fees is the necessary condition of participation and completion of the CGMA Program.
3. All fees paid to AICPA & CIMA are non-refundable and non-transferable between students.
4. New candidates pay a one-time **registration fee**, which includes:
 - Initial registration fee **£99**
Candidate is required to register as a CGMA candidate at [aicpa-cima.com](https://www.aicpa-cima.com) and pay the registration fee by 30 November 2024.
 - First year's subscription fee **Free**
 - Level Objective Tests exemptions
 - 4.1. AICPA & CIMA shall not register a student until fees have been paid in full.
 - 4.2. Registration fee is subject to change on 1st January of each year.
 - 4.3. Existing CGMA candidates continuing their studies in the CGMA Program are not required to re-register or pay the registration fee again if their subscription remains active.
5. The **annual subscription fee** is an obligatory fee for all candidates continuing their studies in the CGMA University Program:

Subscription fee **£139**
Existing CGMA candidates must ensure their subscription is paid before 31 March each year to prevent expiration.

 - 5.1. The subscription year runs from 1 January until 31 December.
 - 5.2. Existing candidates must ensure their subscription is paid before 31 March each year to prevent expiration.
 - 5.3. Annual subscription fee is subject to change on 1st January of each year.
 - 5.4. Undergraduate students of the CGMA Program are exempt from the annual subscription fee for the duration of their first cycle (Bachelor) studies.
 - 5.5. Any student who fails to pay the annual subscription fee will be deleted from the roster of the CGMA Program students, will be unable to proceed to the next level of the CGMA Professional Qualification and will lose access to all online resources and AICPA & CIMA community events.
6. CIMA's CGMA exams are priced based on a tiered structure as part of Association's continued commitment to improving access to qualifications and assessments worldwide. **Exam fees** with a breakdown of eligible countries can be found at: <https://www.aicpa-cima.com/resources/landing/fees>.
 - 6.1. Exam fees are subject to change on 1st January of each year.
 - 6.2. CGMA University Program students are eligible for exam fees applicable for Poland (Tier 2).
